CCN Meeting July 24, 2025

The Columbia Council of Neighborhoods meeting was called to order by the president, Kay Patterson. The participants were welcomed and asked to review minutes received at the sign-in table. There was no financial report presented at this time. Board members for the 2025-2027 service years were presented. Ms. Patterson briefly thanked the audience for electing her as president for this service term. She assured everyone she would put forth her best efforts to help the organization provide communication, service and resources to the participating neighborhoods.

Speakers

Mr. Derek McDaniel- Energy Conservation Program Manager from Dominion Energy

Mr. McDaniel introduced to the audience a program for reducing your heating bill. This program will include home visits to determine your heating efficiency. The program is currently scheduled for designated areas that are 20% below the poverty level. The service will be free for homes that meet the criteria in the designated zones. If your home was built in the 60s or 70s your energy efficiency probably needs to be checked. People who do not live in the currently designated areas are encouraged to call the office at 803.217.4714 for additional information and the possibility of participation. The service is offered to home owners but if you rent or live in an apartment you must have the owner's permission before participating in the program.

Ms. Leigh DeForth- Comprehensive Planner from Columbia Planning and Development Services

Ms. DeForth wanted citizens to know that specific roads and corridors in Columbia will be designated for study to improve traffic flow and safety improvements. Neighbors were asked to be on the look out for information in the Columbia City news information emails and media outlets concerning community input sessions for a variety of areas in the City beginning in August. In October a report of input sessions will be presented to the citizens. This program will be funded by federal grants.
